33- Clean cabinet shelves, in front dispensing area, of some food debris and dried residues (ie: cabinets under sinks). Repair hard to open/ close cabinet doors and drawers where needed.

36- Completely air dry utensils/ food containers on utensil sink drainboard rather than putting utensils away/ stacking while still wet.

44- Clean up/ organize misc. items in back prep/ storage area.
