OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- Employee reports utensil cleaning procedure of wash and rinse. Proper utensil cleaning procedure is wash/rinse and sanitize with an approved sanitizer (i.e.: 1 oz. bleach to 4 gallons water). No sanitizer available by utensil sink or on adjacent storage shelves. Provide.
- 33- Observed saturated wiping rag and accumulation of beverage syrup inside cabinet storing beverage syrup boxes. Clean and repair/replace leaking box/tube.
- 39- No thermometer in display refrigerators storing dairy or Hot Pockets/sandwiches. Provide.
- 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses.
- 45- Observed missing sections of top set coving at entry to back room. Replace. Paint newly repaired walls across from freezer to be smooth and easily cleanable. Clean wall at mop sink (and mop sink faucet) to remove accumulation of grease.
