- OBSERVATIONS AND CORRECTIVE ACTIONS:** 5) Cutting gloves observed being worn for cutting produce without covering with disposable glove over cutting glove.
- 7) Bar refrigerator was 48°F. Cookline prep refrigerator was 46°F. Cookline upright refrigerator was 49°F. Repair
- 10) Cooks were observed to check cooking temperatures on some meats but not others. Probe thermometers were available.
- 14) Clean beverage dispenser nozzles of sticky residues. Clean inside of ice machine of residues. Clean inside bar dispenser gun holder of mold.
- 27) Bar ice scoop stored in non-consumer ice section. 30) Ice bucket and flour container need to be relabeled. 34) No data plate on dishwasher.
- 35) Clean back prep area knife rack of sticky residues. Do not line metal shelves with foil. Use approved shelf liners if needed.
- 41) Drain line for bar hand sink is loose and falls off. Drain line for bar ice bin draining onto floor. One floor sink in cookline was plugged up. Ice bin in wait station was draining onto floor.
- 44) Seal-up all gaps and cracks in walls.
- 45) Clean floor of trash and misc. debris in bar and under ice machine.
