OBSERVATIONS AND CORRECTIVE ACTIONS

- 1- No food safety certificate. Provide documentation within sixty days that at least one person currently working at this facility has passed an approved food safety certification examination. Fax or mail to this Department. Please include name of facility on certificate.
- 14- Food handler reports utensil cleaning procedure of wash and rinse. Proper utensil cleaning procedure is 1. Wash with hot, soapy water, 2. Rinse with clear water, 3. Sanitize with approved sanitizer (i.e.: 1 oz bleach to 4 gallons water), 4. Air dry on clean drain board. Note: Sanitizer observed under sink.
- 29- Observed unlabeled chemical spray container in cabinet by mop sink. Label as to contents.
- 35- Observed domestic chest freezer storing ice cream sandwiches and ice cream. Replace with NSF approved commercial freezer. Note: Domestic upright okay.
- 39- No thermometer observed in display refrigerator (air temperature 39°F) storing bottled milk. Provide.
- 44- Observed wet mop stored in bucket. Store mop so as to dry completely between uses.
