OBSERVATIONS AND CORRECTIVE ACTIONS: 5- Observed food handlers properly washing hands at hand sink during inspection. Kitchen manager reports installation of audible timer by grill set to remind food handlers to properly wash hands every 30 minutes. Manager reports all food handlers aware that 30 minute hand wash is an additional precaution for food safety and that proper hand washing between 30 minute intervals is still required every time hands may have become contaminated (after handling uncooked meats, using restroom, etc.).

Violation corrected. Continue to correct other violations from report dated 10/9/08.
