OBSERVATIONS AND CORRECTIVE ACTIONS

6- Replace/ provide hand sink in prep area. Provide soap and paper towel dispensers at hand sink in prep area. Provide hot and cold water from a mixing faucet and lever-type faucet handles at handsink.

14, 34, 41- Repair/ replace missing utensil sink drain line. Provide utensil sink drain plugs so that utensil sink compartments can be filled for dishwashing. Wash (hot, soapy water), rinse and then sanitize utensils (ie: beverage dispenser nozzles) at utensil sink, in sink compartments rather than reportedly using a bucket.

30, 34, 44- Remove spoils/ returns and misc. items observed on utensil sink drainboards and in mop sink. Utensil sink and mop sink shall be readily available for use.

33- Clean counter at beverage dispenser of sticky residues.

38- Replace burnt out light in walk-in cooler.

44- Provide mop hanger to dry/ store mop after use. Provide a designated storage area for employee's belongings (including lunches).

45- Clean floors in hard to reach areas, under walk-in cooler shelves, around beverage dispenser cabinet of misc. debris, dust accumulation, etc.

Note: Provide additional/ adequate amount of shelf space in walk-in cooler for mobile food facility operating at this facility.
