OBSERVATIONS AND CORRECTIVE ACTIONS

1- Available food safety certificate expired 1/21/03. Provide documentation within sixty days that at least one person currently working at this facility has passed an approved food safety certification examination. Fax or mail to this Department. Please include name of facility on certificate.

14- Food handler reports utensil cleaning procedure of wash with detergent, rinse with sanitizer and towel dry. Proper utensil cleaning procedure is 1. Wash with hot, soapy water, 2. Rinse with clear water, 3. Sanitize with approved sanitizer (i.e.: 1 oz bleach to 4 gallons water), 4. Air dry on clean drain board.

30- Observed muffins and bread stored on front counter in containers lined with paper towels. Remove paper towels. All foods shall be stored on nonabsorbent, easily cleanable surfaces.

35- Observed domestic microwave in use at customer self service counter. Replace with NSF approved commercial unit when current unit becomes nonoperational.
