- 38- Observed missing baffle in hood over Baxter oven.
- 45- Clean floor in hard-to-reach areas to remove some food debris/residues. Raise hose to be off floor under dishwasher to facilitate cleaning. Observed some damaged areas of floor at cove/corner junctions.
