- 14- Observed slicer designated for cheeses to be soiled with meat debris/residues. Slicer cleaned/sanitized during inspection.
- 33- Observed some worn/chipped/damaged areas of cabinets, countertops and drawers. Clean inside cabinets to remove some food/misc. debris/residues.
- 35- Clean along door tracks/corners of hot case and (unsliced) meat/cheese storage case to remove some food debris/residues.
- >Replace eroding insulation covering pipes inside sandwich prep refrigerator to facilitate cleaning.
- >Observed cracked face plate to scale adjacent to meat slicer.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
