- 14- Observed cleaned food pans stacked together wet. Allow pans (utensils) to properly air-dry prior to stacking.
- 35, 36- Observed undersides of bus tubs and food pans, stored on lower prep table shelf, to be soiled with turbid water and food debris/residues. Reported that tubs and pans not regularly used and will be relocated/removed from prep table shelf.
- 45- Replace missing ceiling panels above food service area.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
