OBSERVATIONS AND CORRECTIVE ACTIONS:

- 35) Clean the condensation pans in one of the proofer boxes to remove accumulated residues. Replace the hard-to-clean wooden knife racks (attached to both wooden prep tables) with knife racks that are non-absorbent and easily cleanable. Clean the food storage racks to remove accumulated residues.
- 36) Reported that large mixer bowl is not washed. Wash, rinse and sanitize bowl in place daily.
- 45) Clean floors in hard to reach areas in the dishwasher area.
- 49) Submit application for Permit to Operate to this Department. Facility will be billed during regular school billing cycle.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
