OBSERVATIONS AND CORRECTIVE ACTIONS

- 4- No lids observed on employee's drink glasses.
- 5- Food handler observed with nail polish on fingernails—not wearing disposable gloves.
- 27- Box of bell peppers stored on shelf near raw meat in walk-in cooler.
- 29, 40- Some containers of chemicals and used cleaning rags observed on prep counter near containers of food—moved during inspection; also some containers of chemicals observed on lower shelf near slicer. Either place used cleaning rags in soiled rag hamper for laundering, or soak cleaning rags in container of sanitizer in between uses.
- 34- Provide additional utensil sink drain plugs (one drain plug available at time of inspection) for filling up sink compartments for dishwashing.
- 35- a) Clean major equipment of some food debris/ residues (ie: bottom, inside of storage freezer, inside top of ice machine). Clean bread dough slicer at least every day (slicer is reportedly used daily) rather than less frequently.
 - b) Remove/ replace domestic equipment (ie: crock pot)—all equipment shall be commercial quality and suitable for the intended use.
- 45- Clean floor, in hard to reach areas (ie: under equipment) of some food debris, residues, etc. Clean ceiling, around ceiling vents, of dust accumulation.
