7- Observed chicken on a stick (94°F-115°F) out of temperature at buffet table. Chicken reheated to 165°F for continued hot-holding during inspection. Use available digital probe thermometer to ensure potentially hazardous foods are maintained at 135°F and above or at 41°F and below.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
