**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 14-** Observed some squeeze bottles and bottle lids to be soiled with some greasy-type residues and stored on utensil storage rack.
- 33-** Observed worn countertops and peeling/damaged laminate trim of counters and cabinets (at front sandwich and ice cream service). Continue cleaning accumulated food debris/residues on (sandwich) prep table/refrigerator shelves and inside cabinets/shelving (at front sandwich and ice cream service).
- 35-** Observed inoperable prep refrigerators. Remove or repair refrigerators. Clean along 'pipe' inside ice machine (at top) to remove some mildew. Observed tape on cracked ice cream case lid. Observed shelves supported by buckets and storing misc. cake decorating items; provide approved storage shelving.
- 36-** Observed dried food debris/residues inside bottoms of containers storing plastic ware (forks, knives, spoons).
- 44-** Continue to organize/remove food and non-food related misc. items in back of facility to facilitate cleaning.
- 45-** Continue to clean floors in hard-to-reach areas throughout facility to remove food and misc. debris/residues. Observed damaged/bowed area of FRP at janitorial sink.

Cleaning of utensils, equipment and cabinets/shelving shall be completed and maintained.
