**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 14-** Observed food debris/residues on (reportedly) cleaned electric slicer. Ensure slicer is properly washed/rinsed/sanitized and hard-to-reach areas are cleaned to remove some dried food debris/residues.
- 33-** Continue to clean counters and inside of cabinets at front of both serving areas to remove food and non-food debris/residues.
- 35-** Observed damaged prep refrigerator (i.e. missing handle to broken lid, bottom portion taped closed) at far right end of sandwich counter. Prep refrigerator shall be properly repaired or replaced within next 6 months. Observed some inoperable/damaged equipment stored at front sandwich counter. Repair and/or remove to facilitate cleaning. –Clean inside of ice machine to remove some mold.
- 41-** Repair front hand sink of leak at sandwich counter. –Provide cross-connection for hose at janitorial sink.
- 45-** Observed some damage to wall behind ice cream freezer adjacent to blenders. –Raise pipe lying across floor at front ice cream counter cabinets to facilitate cleaning.
