 31- Observed accumulated residues behind nozzles of beverage dispenser. Clean.
 32- Observed individually wrapped muffins for sale at front counter with no ingredient labels. Provide.
 35- Observed domestic chest freezer storing burritos, etc. in back room. Provide NSF approved commercial unit. Note: Domestic upright okay.
 41- Observed hose connected directly to utensil sink faucet. Provide approved backflow prevention and use every time hose is connected to faucet.
 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses.
 45- Clean floor under beverage syrup rack to remove accumulated dust/debris/residues.
