7- Observed chicken and cheese taquitos (129°F-133°F) and beef and cheese tornados (130°F-135°F) being hot held in hot holding unit. Taquitos and Tornados reheated to 165°F in microwave during inspection. Adjust/repair hot holding unit to maintain potentially hazardous foods at 135°F or above.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
