OBSERVATIONS AND CORRECTIVE ACTIONS

- 1) No food safety certificate available. Owner reportedly signed up for ServSafe class in May.
- 9) Reported that potentially hazardous foods are cooled in an ice bath and then put into large, covered containers to continue cooling in the refrigerator without checking food temperature. Use probe thermometer to ensure that potentially hazardous foods are cooled completely to 41°F or less before storing in large containers. (Note: No cooling observed during inspection).
- 14) Chlorine sanitizer level was 50 ppm at utensil sink. Bleach was added during inspection so that sanitizer level was 100 ppm. Use available sanitizer test papers to check sanitizer levels daily.
- 41) Repair the leak from the plumbing of the utensil sink.
