OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 35- Glass display refrigerator air temperature 50° F at time of inspection—repair/ adjust refrigerator so as to maintain potentially hazardous foods (juices) at 41° F or less.
- 13- Do not add fresh milk to milk already in container at self-serve coffee condiment bar. Wash out container prior to adding fresh milk.
- 30- Replace milk crates, used as storage supports for crates of fruit, also for garbage can, with shelves.
- 33- a) Repair loose portion of copper counter top in front dispensing area—counter is loose at seams creating a cleaning problem.
b) Clean shelves, and counter under espresso machine, in hard to reach areas, of some food debris and dust accumulation.
- 35- a) Clean inside, top of ice machine of mold.
b) Replace rusted shelf in undercounter milk refrigerator.
- 41- Repair leaking utensil sink faucet.
- 45- Clean floors, under equipment, of some food debris and dust accumulation.
