OBSERVATIONS AND CORRECTIVE ACTIONS:

1- food handler signed up to take food safety test on Aug 12
14- wash milk carafe with hot soapy water, rinse and then sanitize with an approved concentration of sanitizer - ie: 1ounce bleach in 4 gal water - rather than just sanitizing with stronger bleach/ water solution
35- clean juice machine, around nozzles of sticky residues
35- replace domestic equipment (toaster, microwave) with commercial equipment

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
