**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 14, 34- Hot water at wash compartment of utensil sink at 100°F. Adjust water heater so as to maintain a temperature of at least 110°F.
- 33- Replace water damaged shelves below front counter (i.e. ice cream stones).
- 34- No test papers available for checking sanitizer level in sanitizer compartment of utensil sink. Provide.
- 38- Replace missing covers on overhead lights in back prep area.
- 44- Mop observed stacked with other brooms near mop sink--hang mop to dry/store.
- 45- Replace broken / missing floor tiles and cove base tiles. RegROUT floor, where grout has eroded out in between floor tiles more than 1/8 inch.
  - Seal gap at ceiling / wall junctures along walk-in coolers.
  - Clean floors of accumulated chocolate residues etc. Clean walls, in hard to reach areas (i.e. behind equipment in back room) of some residues, etc.
