 33) Wood storage pallets in kitchen are only partially painted. Completely paint or replace with NSF approved shelves. 33) No test strips available for dishwasher sanitizer.
 41) No mop sink. Hose has been connect to hot water heater without an approved back flow prevention device.
 45) Clean floors under equipment of misc. debris. Kitchen storage and preparation has moved into the front dispensing area due to lack of space in the kitchen. This area has textured wall paper behind the prep table, non-coved floors, and acoustic ceiling panels. If this temporary building is going to continue in use then the front area needs to be improved to prep standards.
