OBSERVATIONS AND CORRECTIVE ACTIONS

- 1- Food safety certificate not observed. Reported food handler just took food safety certification test. Provide documentation within sixty days that at least one person currently working at this facility has passed an approved food safety certification examination. Fax or mail to this Department. Please include name of facility on certificate.
- 27- Observed food prep table used to make tacos to be overly crowded (three flats and one box juice, paper towels, etc.). Keep table clear for food preparation so as to prevent accidental contamination/cross-contamination.
- 30- Observed bag of pretzels stored on top of opened, uncovered package of precooked bacon in refrigerator. Keep foods covered to prevent contamination. Observed boxes of taco wraps and cheese cups to be stored on floor. Store foods at least six inches off floor on approved shelving.
- 35- Observed domestic microwave in use. Replace with NSF approved commercial unit.
- 45- Observed patched strip of vinyl flooring (from utensil sink to end of prep table) to be lifting/separating. Repair and properly heat seal to prevent further damage to floors.
