 35- Observed domestic microwaves in use. Replace with NSF approved commercial units. Note: Additional domestic microwave added since last inspection. NSF approved, commercial equipment required in permitted food facilities.  
 45- Observed vinyl flooring to be separating/lifting by utensil sink and back room floor sink and splits in coving by hand sink. Observed rough patch on south wall by freezer. Repair all to be smooth and easily cleanable. *Note: No food handlers present during inspection.*

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
