OBSERVATIONS AND CORRECTIVE ACTIONS: 1) No food safety certificate available during inspection. Fax copy when found.

5, 6) Both prep area hand sinks blocked by purses or utensils. No paper towels in dispensers. Keep hand sinks stocked and accessible. Don't use utensil sink for handwashing.

7) Display refrigerator was 49°F. Repeat violation. Repair or replace unit.

9) Do not cool quiche or PHF pies in display refrigerator. Cool in storage refrigerator first.

27) Rolls on table with paperwork and other non-food related items in office. Keep office supplies separate from food and food contact surfaces.

35) Clean inside ice machine of some mold. Replace ice bin with exposed cooling tubes or do not store consumer ice in unit within 6 months.

36) Clean utensil bins of food debris and sticky residues.

40) Soiled wiping rags observed on equipment. Keep in bucket of sanitizer and check level of sanitizer with test strips. 41) Repair spray hose to rest above rim of sink.

44) Purses and other employee items stored on ice machine and other areas of kitchen. Store in separate, designated place. 45) Clean floors of misc. debris in hard to reach areas.

Reinspection fees will be charged for all subsequent reinspection unless an acceptable corrective time schedule has been submitted and approved by this Department.
