OBSERVATIONS AND CORRECTIVE ACTIONS:

- 6- Observed paper towels dispenser at kitchen handsink to be stuck and roll of paper towels atop dispenser. Repair stuck dispenser, or replace.
- 14- Observed some cleaned/sanitized utensils (i.e. prep bowls, colanders, bus tubs) stacked together wet. Allow utensils to properly air-dry prior to stacking/storage.
- 45- Continue to clean floor under cookline equipment, especially fryers, to remove food debris, greasy residues. Provide means so as to make equipment and floors easily accessible and to facilitate cleaning (i.e. equipment on casters).

Necessary violations have been corrected and no further reinspections to follow at this time. Time/temperature logs for cooling of cooked foods provided and ok.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
