**OBSERVATIONS AND CORRECTIVE ACTIONS:** 1) No food safety cert. available. However, cook was very knowledgeable.

6) Back kitchen hand sink was partially blocked. Front kitchen sink is used the most.

9) One medium size container of soup was observed to be cooling at 4 inch depth. Cool soups in small container or at 2 inch depths in the walk-in cooler.

14) Wood cutting board is only wiped off with sanitizing solution throughout day. The cutting board may periodically be wiped off with a wiping rag solution that is **only** used for food contact surfaces. However, at least every 4 hours, the cutting board must be properly washed, rinsed, and sanitized.

32) No ingredient labels on displayed, packaged sandwiches and salads.

35) Clean beverage dispenser of sticky and reddish residues around nozzles and at ice shoot.

36) Clean knives and knife rack of sticky residues.

39) One front refrigerator thermometer is in disrepair.      45) Clean floors under equipment of misc. debris and grease.
