- 25) Note: Remind food handlers that if they wear large rings they must wear disposable gloves when handling any unpackaged foods or clean utensils.
- 29) Relocate produce wash dispenser away from janitorial sink area.
- 45) Repair roof leak in back.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
