**OBSERVATIONS AND CORRECTIVE ACTIONS:** 28- Employee reports apples offered for sale as ready to eat food are not washed prior to placement at front counter. Also reported apples don't need to be washed as they are "washed" by sprinklers in main store. Properly wash all apples, pears, etc. at prep sink before offering for sale as ready-to-eat food.

30- Observed apples at front counter stored in cloth-lined basket. Remove cloth. Store foods on nonabsorbent surfaces only.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
