OBSERVATIONS AND CORRECTIVE ACTIONS:

11, 36- Reported (precooked) hot dogs and Polish dogs are being placed in hot-holding unit from refrigerator without being rapidly reheated to 135°F prior to. Hot dogs and Polish dogs were placed on grill for reheating during reinspection. Reported that cooker/warmer unit will be obtained to rapidly reheat precooked hot dogs, and similar, to 135°F. It is understood that Italian sausages, which are raw, shall be rapidly cooked to 165°F prior to hot-holding (at 135°F).

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
