OBSERVATIONS AND CORRECTIVE ACTIONS: 5- Observed food handler cooking raw chicken at grill remove gloves, pick up visibly soiled pan of raw chicken and place in refrigerator then go into walk-in refrigerator without washing hands. See #5 on back of this form for times hand washing is *required*.

7- Observed assorted cooked meats (104°F-127°F) being hot held on steam table. Adjust/repair and monitor unit to maintain potentially hazardous foods at 135°F or above. Note: Unit turned up, meats re-heated to 165°F during inspection.

31- Clean around nozzles of beverage dispenser to remove accumulated residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
