OBSERVATIONS AND CORRECTIVE ACTIONS: 33- Clean inside cabinet under beverage dispenser to remove residues.
 35- Observed cracks in freezer lids. Repair to be smooth and easily cleanable. Clean behind and between nozzles of beverage dispenser to remove accumulated residues.
 36- Observed clean blender pitchers stored directly under paper towel dispenser by hand sink. Relocate to prevent accidental contamination.
 41- Observed hand sink faucet to be loose. Tighten to prevent water damage to interior of cabinet.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
