7) Observed French fries 126°F in the hot-holding drawer (air temperature 145°F). Fries were placed back into oven to be re-heated during inspection. Ensure that fries are heated to 135°F before being placed into the hot-holding unit.

52) Generally clean/organize the back room where athletics ice machine and freezer are stored. Clean the outside of athletics ice machine to remove accumulated dust/residues.
