OBSERVATIONS AND CORRECTIVE ACTIONS

7, 35- Observed pieces of chicken (113°F-114°F) and ground beef in tacos (94°F-97°F) out of temperature in hot holding unit. Adjust/repair hot holding unit to ensure potentially hazardous foods are maintained at 135°F and above. Observed cartons of chocolate milk (55°F-56°F) sitting out by cash register. Keep milk in refrigerator to ensure it is maintained at 41°F or below.

30- Observed boxes of chicken stored on floor in walk-in freezer. Store foods at least 6 inches off floor on approved shelving.

35, 39- Observed digital temperature indicator on hot holding unit to be fluctuating rapidly. Repair or provide interior thermometer to properly monitor temperatures for hot holding.

45- Observed damaged floor tiles through out kitchen. Repair where needed.
