OBSERVATIONS AND CORRECTIVE ACTIONS

7- Observed hamburgers (124°F-125°F) and fish nuggets (129°F-133°F) in hot holding unit. Reported hamburgers and fish nuggets heated to 140°F before placement in hot holding unit. Adjust/repair unit to maintain hot held foods at 135°F or above.

14- Hot water in wash basin of utensil sink 104°F during inspection. Maintain wash water at 110°F or above whenever wash basin is filled. Three compartment utensil sink set up to wash/sanitize/rinse. Proper utensil cleaning procedure is wash/rinse/sanitize.

26- Observed packaged deli sliced turnkey (35°F-40°F) defrosting at room temperature. Use approved method to defrost foods (under running water, in refrigerator, etc.).

39- Observed available digital probe thermometer—used to check temperature of thin foods—to be non-operational. Change battery/replace. Note: Dial thermometer available.
