 34- Observed paper towels stuffed around plugs in all compartments of filled utensil sink. Reported sink unable to hold water with plugs only.
 Discontinue use of paper towels. Replace improperly functioning plugs with plugs capable of maintaining water in utensil sink.
 36- Observed scoop used to serve pineapple stored with handle on/in food. Store handle out/off of food so as to prevent contamination of food.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
