OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- No detectable sanitizer in dishwasher. Service company called and dishwasher repaired during inspection. Use available sanitizer testing strips to ensure sanitizer residual of at least 50 ppm.
- 21- No hot water at restroom hand sink used by food handlers. Provide. REPEAT VIOLATION
- 36- Observed eating utensils at student self-service table stored with handles in both directions. Store all eating utensils with handles in same direction to prevent contamination of eating surfaces by student hands.
- 45- Observed cracks between floor tiles under dishwasher. Seal/repair to prevent water damage to floor. Repair holes /damaged area on wall behind dishwasher to be smooth and easily cleanable. Clean ceiling and condenser drain pipe in walk-in refrigerator to remove black residues.
