OBSERVATIONS AND CORRECTIVE ACTIONS

1- No food safety certificate for current food handlers available at time of inspection. Fax copy of food safety certificate to this Dept. (include name of facility on fax).

4- No lid observed on food handler's coffee cup; observed on shelf above prep table.

27- Temperature of potentially hazardous (refrigerated) foods reportedly not being checked at time of delivery. Use probe thermometer to check temperatures of delivered foods.

30- Some cardboard boxes of produce (oranges) stored on floor in walk-in cooler.

33- Refinish worn/ rusted areas of cabinet shelves above utensil sink.

38- Replace missing cover on overhead light in walk-in cooler.

44- Back screen door left open—closed during inspection. Keep screen door closed to prevent fly/ insect entry.

45- Clean floor, in hard to reach areas (ie: under major equipment, shelving, etc), of dust accumulation and misc. debris.

Note: Check sanitizer level in rinse cycle of dishwasher on a daily basis rather than reportedly every few days.
