OBSERVATIONS AND CORRECTIVE ACTIONS: 7- Observed hamburgers (103°F-105°F along pan edges) and ground beef (127°F) being hot held in hot holding cabinet. Reported hamburgers and ground beef heated to 165 °F prior to placement in cabinet but cabinet recently turned on. Ensure hot holding unit is at proper hot holding temperature (135°F+) before placing potentially hazardous foods in unit.

Note: Ground beef and hamburgers returned to oven to be reheated to 165°F during inspection.

35- Replace damaged oven door handle to facilitate cleaning.

45- Observed cracked/peeling paint on wall above and below utensil sink and on ceiling over oven. Repair to prevent contamination of open food and clean utensils.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
