OBSERVATIONS AND CORRECTIVE ACTIONS: 35- Hot-holding warming cabinet internal air temperature 115.9°F (inspector's thermometer) and 116.2°F (cabinet's thermometer). Reported that cabinet is unable to maintain cooked/warmed potentially hazardous foods at proper hot-holding temperature (135+°F).

Repair/replace cabinet. **Note:** No foods were being held in cabinet at time of inspection.

45- Clean floors in hard-to-reach areas of dust and misc. debris. -Observed pest control glue strips to be full of dead cockroaches. Replace. -Clean floor in utensil storage room/office to remove some dried rodent droppings.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
