OBSERVATIONS AND CORRECTIVE ACTIONS: 6, 21- No hot water at restroom hand sink used by food employees. Provide to prevent spread of harmful bacteria.
 29- Observed two unlabeled chemical spray containers in utensil cleaning area. Label as to contents.
 30- Observed boxes of food stored on floor in storage room and walk-in freezer. Store foods at least six inches off floor on approved shelving.
 45- Observed split in vinyl flooring by walk-in refrigerator and vinyl to be lifting/separating at drain by prep sink. Repair to prevent further damage to floor and to prevent harborages. Replace missing ceiling panel over prep table.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
