 9- Observed cooked pinto beans which had reportedly been cooled, in uncovered containers at depths of 2 inches. Violation corrected.  
 14- Observed hot water in wash cycle of dishwasher at 114°F. Adjust/repair unit to maintain 120°F in wash cycle. Note: Sanitizer at 50+ppm.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
