**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 7- Observed Half and Half at 48°F in carafe at customer self-service counter. Maintain at 41°F or below.
- 9- Observed cooked pasta (48°F, 3 hours) cooling in covered pot at depths varying between 1 and 3+ inches. Pasta uncovered and evened out (to maximum 2 inches) during inspection to complete cooling process.
- 21- No hot water at restroom hand sink. Provide.
- 30- Observed assorted foods (bags of sugar and flour, bottles of vanilla and To-Go containers, etc.) stored in cabinet in rest room. Relocate. No food or food related items shall be stored in restroom. Replace soiled cardboard box storing produce in refrigerator with nonabsorbent, easily cleanable container.
- 33- Observed damaged areas on counter by coffee brewer and by hand sink. Repair to be smooth and easily cleanable.
- 35- Clean equipment (refrigerators, freezer, etc.) to remove food debris/residues.
- 44- Observed both windows and front and back door open on arrival. Keeps doors and windows closed or provide screened doors and screens on windows to prevent entrance of flies.
