OBSERVATIONS AND CORRECTIVE ACTIONS

- 14-** Observed electric slicer soiled with some dried food debris/residues in hard-to-reach areas.
- 33-** Continue to clean inside cabinets at front (across from Panini station) to remove dried food and misc. debris/residues. Clean countertops under equipment at beverage area to remove some food and dusty residues. Clean undersides of stainless steel shelves affixed to walls (in kitchen and front) to remove some food and dusty residues.
- 35-** Clean inside/between/hard-to-reach areas of cookline equipment to remove accumulated dust and blackened food debris/residues. Reported casters will be ordered to facilitate cleaning of cookline equipment. –Clean outside of rotary mixer to remove food debris. –Remove unused hot-holding unit (storing soup bowls), and crate under unit, to facilitate cleaning. –Clean inside ice machine to remove some mildew.
- 45-** Continue to clean floors in hard-to-reach areas to remove some dried food debris/residues and misc. trash. Clean wall behind affixed magnetic knife rack in kitchen to remove some food residues. Clean ceiling, top portion of walls and inside hood of kitchen to remove some dusty residues.
