OBSERVATIONS AND CORRECTIVE ACTIONS

29- Spray can of domestic insecticide observed in janitorial cabinet near mop sink.

34- a) Rack of dishes observed on counter near utensil sink—air dry dishes on utensil sink drainboard (OK to use dish rack on drainboard) rather than on countertop.

b) Check concentration of sanitizer (bleach) added to sinkful of water to verify adequate concentration of sanitizer (ie: 1 ounce bleach in 4 gal. water).

Note: No dishes being washed during inspection.

35- Defrost undercounter freezer (ie: at doors) where needed.

39- Replace broken thermometer in undercounter freezer (15° F).

44- Remove employee's personal items (crockpots in cabinet).

45- Clean floor, under major equipment (ie: stove), of misc.debris.
