OBSERVATIONS AND CORRECTIVE ACTIONS: 9- No foods observed cooling during inspection. Reported sauces cooled in ice bath and other foods (chicken, whole beans, etc.) cooled in single layer of shallow, uncovered containers. Also reported foods cooked in smaller batches so as to decrease amount of food cooling in refrigerator at one time. Violation corrected.

23- Observed a few rodent droppings in wait station and back room storing refrigerators. Clean and continue working with Pest Control Operator to abate.

35- Observed ground beef (146°F) being held in nonoperational lower section of oven. Store potentially hazardous foods in equipment capable of maintaining required temperatures (135°F and above).

38- Observed lights over prep table to be nonworking. Replace bulbs/repair ballast.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
