OBSERVATIONS AND CORRECTIVE ACTIONS

- 1)** No food safety certificate available upon inspection. Provide this office (fax/mail) a copy of a valid food safety certificate for at least one current employee within 60 days.
- 35)** Remove or replace heavily worn/damaged wood cart.
- 38)** Replace missing light covers or end caps for lights in food prep areas.
- 41)** The floor sink next to dishwasher is draining slowly. Repair. Waste water from the ice machine is being discharged onto the ground outside of facility. All liquid waste must drain to an approved fully functioning sewage system.
- 45)** Replace floor with durable, smooth, non-absorbent, easily cleanable and self-coved floor surface within one year.
