OBSERVATIONS AND CORRECTIVE ACTIONS

7- Observed large cut uncooked beef (52°F) and cooked chicken (51°F-52°F) in two door refrigerator (air temperature 46°F). Unit adjusted down during inspection. Monitor to ensure foods in refrigerator are maintained at 41°F or below.

Note: Air temperature of approximately 38°F may be required to keep foods at 41°F.

9- No foods observed cooling at time of inspection.

23- Observed cockroach nymphs in cabinets at hand sink, in back by stereo and in cabinet housing microwave. Contract with Pest Control Operator to abate.

Notes: a) Food handler reports initial appointment with pest control company within two hours and that owners are trying to arrange treatment after regular business hours today, tomorrow or Sunday when facility is closed. If unable to schedule appointment after regular business hours, facility shall make arrangements to close early, open late or take other steps necessary to ensure facility is completely and professionally treated before opening Monday.

b) Observed all cabinets to have been cleaned and back room to have been cleared of accumulated debris, miscellaneous trash, etc.
