OBSERVATIONS AND CORRECTIVE ACTIONS

- 4- Observed plate with half eaten meal—reportedly an employee's—sitting on food prep table. Food handlers/employees shall not eat in food preparation areas. Note: Plate removed to utensil sink during inspection.
- 39- No thermometer observed in food prep refrigerator. Provide.
- 44- Observed large opening in window over air conditioner and large gaps around warped wood sealing vent between kitchen and outside. Verify vent is screened or replace wood and provide screen for opening over air conditioner or keep window closed to prevent the entrance of flies and bees.
- 45- Observed coving pulling away from wall in restroom, deteriorating sealant around base of toilet and sections of vinyl flooring by dishwasher/prep table to be separating. Repair all to be smooth and easily cleanable. Observed large cracks in ceiling paint over stove and prep refrigerator. Repair to prevent contamination of food.
