OBSERVATIONS AND CORRECTIVE ACTIONS:

- 14- Manager reports shake wands are cleaned with water and sanitizer. Wash/rinse/sanitize wands after each use or every four hours of continuous use.
- 36- Observed cup used as scoop in parmesan cheese in refrigerated drawer at cook line. Provide handled scoop. Observed butter scoop (wait station) stored in still water in dipper well. Run water in dipper well once utensils have been used. .
- 39- No thermometer in right hand wait station refrigerator. Provide. Relocate thermometer in dessert display refrigerator so as to be visible.
- 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses. Observed unsecured CO2 tanks in back prep area. Secure to rigid structure.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
